Theodore Ahlers is a Senior Advisor of the Emerging Markets Forum. He is an economist with extensive experience in Europe, Central Asia, the Middle East & North Africa, and Sub-Saharan Africa. He advises numerous countries and institutions on strategic economic issues and edited *Africa Reset: A New Way Forward* (Oxford 2017) and contributed to *Central Asia 2050: Unleashing the Region's Potential* (Sage 2016). Over the previous 25 years, he held economist and senior management positions at the World Bank, including Strategy and Operations Director for Europe & Central Asia (2007-12), Maghreb Department Director (2002-07), Strategy and Operations Director for Africa (2000-02), Country Director for Benin, Niger, and Togo (1996-2000), and Lead Economist in West and Central Africa (1994-96). He holds a PhD in Development Economics from Tufts University, Fletcher School.

Shri Montek Singh Ahluwalia was until recently the Deputy Chairman of the Planning Commission for India. He has been a key figure in India's economic reforms from the mid 1980s onwards.

Born on 24th November, 1943, Shri Ahluwalia received his Bachelors degree from St. Stephens College, Delhi University. Later he received an M.A. and an M. Phil degree in economics from Oxford University, where he was a Rhodes Scholar. After completion of studies, he joined the World Bank in 1968 as a Young Professional and then held various positions including Chief of the Income Distribution Division.

He joined the Government of India in 1979 as Economic Adviser in the Ministry of Finance after which he held a series of positions including Special Secretary to the Prime Minister; Commerce Secretary; Secretary in the Department of Economic Affairs; Finance Secretary in the Ministry of Finance; Member of the Planning Commission and Member of the Economic Advisory Council to the Prime Minister. In 2001, he was appointed as the first Director of the newly created Independent Evaluation Office of the International Monetary Fund. He resigned the position in 2004 to take up the position of Deputy Chairman of the Planning Commission which position he holds at present.

Shri Ahluwalia has written on various aspects of development economics, including Indian economic policy and his articles have been published in a number of prominent Indian and international journals and books. He co-authored 'Re-distribution with Growth: An Approach to Policy', published in 1975. He also wrote 'Reforming the Global Financial Architecture', which was published in 2004 as Economic Paper No. 41 by the Commonwealth Secretariat, London.

Shri Ahluwalia has received several honorary degrees including an honorary doctorate in Civil Law from the University of Oxford. He is an honorary fellow of Magdalen College, Oxford and a Member of the Board of Directors of the Global Green Growth Institute, South Korea.



Masood Ahmed

Masood Ahmed is president of the Center for Global Development. He joined the Center in January 2017, capping a 35-year career driving economic development policy initiatives relating to debt, aid effectiveness, trade, and global economic prospects at major international institutions including the IMF, World Bank, and DFID.

Ahmed joined CGD from the IMF, where he served for eight years as director, Middle East and Central Asia Department, earning praise from Managing Director Christine Lagarde as a “visionary leader.” In that role, he oversaw the Fund’s operations in 32 countries, and managed relationships with key national and regional policy makers and stakeholders. In previous years, he also served as the IMF’s director of External Relations, and deputy director of the Policy Development and Review Department.

From 2003-2006, Ahmed served as director general, Policy and International at the UK government’s Department for International Development (DFID). In that role, he was responsible for advising UK ministers on development issues and overseeing the UK’s relationship with international development institutions such as the World Bank.

Ahmed also worked at the World Bank from 1979-2000 in various managerial and economist positions, rising to become Vice President, Poverty Reduction and Economic Management. In that role he led the HIPC (heavily indebted poor countries) debt relief initiative, which has to-date brought relief from debt burdens to 36 of the world’s poorest nations.

Born and raised in Pakistan, Ahmed moved to London in 1971 to study at the LSE where he obtained a BSc Honors as well as an MSc Econ with distinction. He is a UK national.

Ahmed is a leading expert on Middle East economics, having served on the Advisory Board of the LSE Middle East Center, as well as on the World Economic Forum’s Global Agenda Council on the Middle East and North Africa. He has also participated in CGD’s Advisory Board.

He took over as CGD president from Nancy Birdsall, who served as the Center’s founding president for its first 15 years from 2001 and will stay at the Center as a senior fellow.



Alex Aleksishvili

Mr. Aleksishvili, Chairman of the Board at Policy and Management Consulting Group (PMCG), has 15 years of working experience in public finance and economic development policy sector as a high level government official and the government adviser responsible for budget and financial policy, tax and customs policy reform, simplification of doing business environment and improving investment climate.

While working as a Minister of Finance of Georgia, successfully conducted series of reforms in Public Finance, Tax and Customs Policy and Administration, Economic Deregulation and Liberalization domains. Georgia was ranked by the World Bank "Doing Business" survey as the world's #1 reformer country in 2005-10. During this period (2004-2007), Georgia improved from 132nd place to 18th in the ranking of "Ease of Doing Business" by the World Bank.

As a Minister of Finance (2005-2007), conducted Public Finance Management, Tax and Customs reforms. As a result of comprehensive policy reforms, Georgia's GDP growth rate in 2005-2007 overreached 10% on average (2005 - 9.6%, 2006 - 9.4% and 2007 - 12.3%). FDI has been increased from 250 m USD in 2004 to 2,100 m USD in 2007.

In addition, Mr. Aleksishvili was elected as a Chairman of UN Commission for Sustainable development in 2005-2006.

Abdelaaziz Ait Ali is a principal Economist and head of the Research Department at the Policy Center for the New South. He joined the Center in 2014 after five years of experience at the Central Bank of Morocco. He worked as an economist in the International Studies and Relations Department and was analyzing the real estate price index and financial asset prices for monetary policy and financial stability purposes. Since then, Abdelaaziz has focused on cyclical and structural issues of the Moroccan economy, including macroeconomic management and industrial policy design. He has published articles on the reform of the exchange rate regime in the Moroccan economy and its implications for macroeconomic regulation, as well as on the evolution of the macroeconomic framework over the last two decades. A. Ait Ali has examined the implications of the recent health crisis and published articles on the macro, social and regional impacts of the pandemic on the Moroccan economy. He has also contributed to the evaluation of industrial policy in light of the challenges facing the Moroccan economy and the new global context. He published an article on the role of the manufacturing sector in growth and made recommendations for a better design and implementation of industrial policy. Abdelaaziz A. Ali holds a Master's degree in econometrics from Hassan II University in Casablanca.

Adrian Armas has been Chief Economist of the Central Reserve Bank of Peru (BCRP) since 2005, except 2017-2018, when he was the Executive Director for Argentina, Bolivia, Chile, Paraguay, Peru, and Uruguay at the IMF Board. He has spent most of his career (since 1986) at the BCRP, where he was previously Head of the Monetary Policy Division (1997-2005) and Chief of the Financial Programming Section (1995-1997). He contributed to the design and implementation of Peru's inflation targeting scheme and has written articles on this subject and others on central banking for the IMF, BIS, the LACEA Journal, and several central banks. He participated in IMF technical assistance missions as MCM Advisor in 2007-2017 and India in 2022. He has taught Econometrics, International Economics, Macroeconomics, Monetary Theory and Political Economy at several Peruvian universities. He holds an M.A. degree in Political Economy from Boston University (1992).

Abdelhak Bassou is a Senior Fellow at the Policy Center for the New South and a non-resident senior fellow at the Atlantic Council's Africa Center. He is also an Affiliate Professor at Mohammed VI Polytechnic University. Bassou has had an extensive career in Moroccan National Security, where he served in various capacities including as head of the border division from 1978 to 1993. He was the former director of the Royal Institute of Police in 1998 and served as Head of Regional Security (Errachidia 1999-2003, Sidi Kacem 2003-2005) and as Central Director of General Intelligence from 2006 to 2009.

He holds a master's degree in political science and international studies from the Faculty of Law, Economics, and Social Sciences in Rabat. His academic research delves into international rivalries, geopolitical analysis, and pressing security issues such as conflicts and terrorism in Africa.

Since 2018, Bassou has been directing and editing the collectively written annual report on Africa's geopolitics, which is published by the Policy Center for the New South. His work has been disseminated through numerous prestigious think tanks and institutions. Notable contributions include 'Towards EU-MENA Shared Prosperity' (Bruegel, 2017) and 'Evolving Human Security Challenges in the Atlantic Space' (Jean Monnet Network, 2019). He is also a frequent contributor and participant in the HEC-PCNS Strategic Dialogues and their corresponding written volumes.

Mr Mohamed Béavogui, an expert in Agricultural Finance, was elected as the first African General Manager of the African Risk Capacity in January 2015 during the 3rd annual Conference in Addis Ababa, Ethiopia. In September 2015, he took over from interim Director-General, Dr. Richard Wilcox.

Mr Béavogui has over 25 years of international experience in development, and previous to his appointment with ARC was the Director of Partnerships and Resource Mobilization and Senior Advisor to the President of the United Nations International Fund for Agricultural Development (IFAD).

He joined IFAD in 2001 as Director of Programs for West and Central Africa and was responsible for delivering the lending and grant program, and managing a large portfolio of projects.

Prior to joining IFAD, he worked for 7 years with the United Nations Office for Project Services (UNOPS) in New York as a Senior Project Management Officer and subsequently as Regional Director for West and Central Africa. Earlier, he worked at the Food and Agriculture Organization of the United Nations (FAO) in Burundi as Chief Technical Adviser and in Rome. Before this, Mr Béavogui worked in the African Regional Centre for Engineering Design and Manufacturing (ARCEDEM) in Nigeria, and for the Government of Guinea.

He is a member of several panels working on regional and global issues related to food security and rural development, and the recipient of several honours and awards.

Mr Béavogui holds a Master's degree in Engineering from Saint Petersburg Polytechnic, a Bachelor's degree in Mechanical Engineering from G.A Nasser University, and undertook Executive Management Training at Harvard Kennedy School.

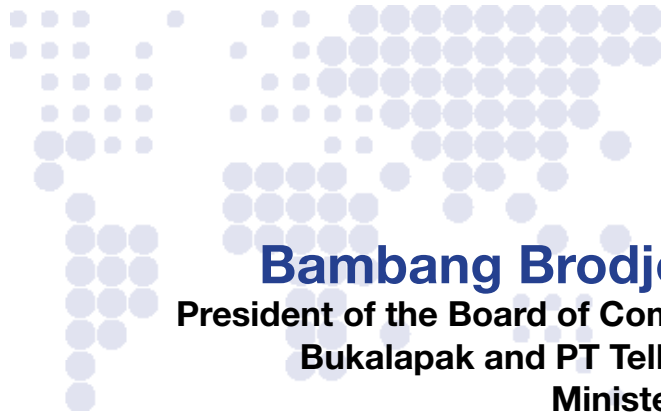

On 4 July 2022, Mr Brou took office as Governor of the Central Bank of Western African States (BCEAO). From March 2018 to June 2022, he was President of the Commission of the Economic Community of West Africa (ECOWAS) in Abuja, Federal Republic of Nigeria.

Prior to his appointment as President of the ECOWAS Commission, Mr. Jean-Claude Kassi Brou was, in turn, Minister of Industry and Mines in Côte d'Ivoire since November 2012 (the Mines portfolio awarded to him in July 2013), Resident Representative of the World Bank for Chad between 2010 and 2012.

In this career at the national level, Mr. Brou occupied between 1990 and 1995 the position of economic and financial adviser to the Prime Minister of Côte d'Ivoire before being appointed in 1996, Director of Cabinet to the Prime Minister, a position that he will remain until 2000. Alongside this function, he was President of the National Privatization Commission and led, in this capacity, an ambitious program of reforms which enabled the privatization of seventy (70) public companies operating in various economic sectors.

In addition, between 2000 and 2008, Mr. Brou held senior positions at the Central Bank of West African States (BCEAO). He successively held (between 2000 and 2003) the position of Director of International Relations, in particular in charge of economic integration policies in the West African Economic and Monetary Union (UEMOA), Director of Studies until 2005 then Director of the Economic and Monetary Department between 2006 and 2007 before being appointed in 2007 Principal Advisor and General Comptroller of the Institution.

Mr. Brou began his professional career in 1982 at the International Monetary Fund (IMF) as an economist, then as a principal economist before occupying the post of Resident Representative of the IMF in Senegal between 1990 and 1991.



Michel Camdessus

Founding Co-Chairman of the Emerging Markets Forum and former Managing Director of the International Monetary Fund, Mr. Camdessus is Governor Emeritus of Banque de France. He was a member of the Africa Progress Panel, chaired by late Kofi Annan, and a member of the Commission for Africa, chaired by the then British Prime Minister, Tony Blair. Mr. Camdessus was the Chairman of the World Panel on Financing Water Infrastructure. He has been appointed as the Chairman of the French Government's several working groups in charge of preparing the economic, social, and structural policies reforms.

Mr. Camdessus was educated at the University of Paris and earned post graduate degrees in economics at the Institute of Political Studies of Paris (Institut d'Etudes Politiques de Paris) and the National School of Administration (ENA). Following his appointment as Administrateur Civil in the French Civil Service, Mr. Camdessus joined the Treasury in the Ministry of Finance in 1960. After serving as Financial Attaché to the French delegation at the European Economic Community in Brussels from 1966 to 1968, he returned to the Treasury and went on to become Director in February 1982. During the period 1978–84, Mr. Camdessus also served as Chairman of the Paris Club, and was Chairman of the Monetary Committee of the European Economic Community from December 1982 to December 1984. Mr. Camdessus was appointed Governor of the Banque of France in November 1984. He served in this capacity until his election as Managing Director of the IMF in 1987. On May 22, 1996, the Executive Board of the IMF unanimously selected Mr. Camdessus to serve a third five-year term as Managing Director, beginning January 16, 1997. Mr. Camdessus retired from the IMF on February 14, 2000.

In 2021, President Macron awarded the highest civilian honor in France, the Grand' Croix dans l'ordre national du Mérite, to Mr. Camdessus.

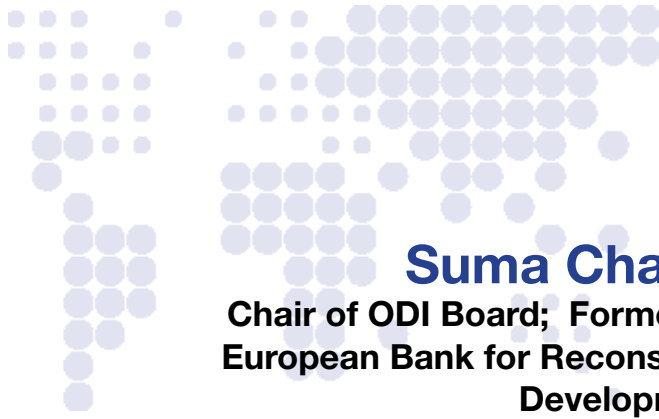

In Portugal, he held research, training and management posts in several universities (1991-2021) and was coordinator of the Africa programme at the Institute for Strategic and International Studies, IEEI (1991-2012). He was Chairman of the Steering Committee of the Europe-Africa Policy Research Network, EARN (2007-2014). As a consultant, he has prepared and evaluated several cooperation programmes in Mozambique, Angola, Cape Verde and the PALOP group, for Portuguese and European entities. He is a regular contributor to the Institute of National Defence and the Institute of Military Studies and an occasional commentator on African and international relations in various media. In recent years, his studies have focused on development studies, geo-economics and security, with a particular emphasis on Africa.

Sir Suma Chakrabarti, born in 1959 in West Bengal, India, is the sixth President of the European Bank for Reconstruction and Development (EBRD). The EBRD's Board of Governors re-elected Sir Suma as President of the Bank for a second four-year term in 2016. He began his first term in 2012, having replaced Thomas Mirow. Sir Suma has extensive experience in international development economics and policy-making, as well as in designing and implementing wider public service reform. Before arriving at the EBRD, he held the position of Permanent Secretary at the British Ministry of Justice and was its most senior civil servant. Prior to this, from 2002, he headed the UK's Department for International Development (formerly the Overseas Development Administration (ODA) where he worked closely with economies undergoing substantial reform in eastern Europe, the former Soviet Union and the Middle East and North Africa. Sir Suma is notable for playing a key role developing the UK's successful Know-How Fund for Central and Eastern Europe and worked with the European Commission in improving its programmes in the Middle East and North Africa. Sir Suma also worked in the late 1990s in the UK Treasury, where he was responsible for UK public expenditure, and in the early 2000s in the Cabinet Office, where he led on cross-departmental strategic issues and subsequently the management of the Cabinet agenda. After studying Politics, Philosophy and Economics at the University of Oxford, Sir Suma took a Masters in Development Economics at the University of Sussex. He also holds honorary doctorates from the Universities of Sussex and East Anglia and the Bucharest University of Economic Sciences.

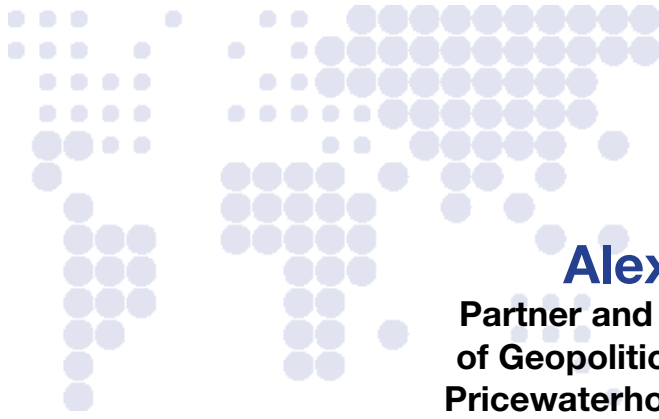


Kevin Cleaver is a consultant specializing in International development, development economics and agriculture. He currently works with the Centennial Group (Washington, DC) preparing a chapter on global agriculture for a forthcoming book on global development. He is the chairperson for the Agriculture and Rural Development Thematic Group of the World Bank's 1818 Society (of alumni and retirees). Dr. Cleaver is also co-owner with his wife, Maria Nikolov, of a farm in Peru which produces coffee and cacao. They have created a project to assist Peru's park service to manage the Abiseo Park in Peru (a World Heritage site), including buffer zone activities to protect the park.

Prior work with Centennial has included supporting preparation of the African Development Bank's new agriculture strategy; assessing FAO's technical capacity; preparing a chapter on agriculture for a book entitled "Africa Reset" by the Centennial Group; an evaluation of the agriculture situation in China for the Asian Development Bank, and an evaluation of the Asian Development Bank's agricultural strategy and projects. Dr. Cleaver was the Associate Vice President (Assistant Secretary General in the common UN system), for Programs of the International Fund for Agriculture Development (IFAD) (a specialized agency of the United Nations) from 2006 to 2014. During 2002–2006, he was the Director for Agriculture and Rural Development for the World Bank Group. He also held various positions in the World Bank, including Director for Environment, Rural Development and Social Development in the Europe and Central Asia Region of the World Bank, Technical Director for the Africa Region of the World Bank, and Agriculture division chief in the Africa Region (1976–2002). Prior to joining the World Bank, he was an economist in Zaire's Ministry of Finance while completing research for his PhD. He has a number of publications on agriculture and on the environment.

Dr. Cleaver earned his Ph.D. in Economics from the Fletcher School of Law and Diplomacy, Tufts University (1975). He has a Master's Degree in International Law and Diplomacy, Tufts University (1973). He received a Bachelor of Arts degree (major in international relations and minor in economics) from the University of Pennsylvania (1970). He also received a World Bank-sponsored executive training program in Harvard Business School in 1995.

Dr. Cleaver has several awards, including the 2014 IFAD President's Award, and the Chevallier de l'Ordre du Merit Agricole awarded by the French government.

Dr. Roberto F. de Ocampo, former Secretary of Finance of the Philippines, became the first Filipino to receive the most internationally prestigious award to Finance Ministers, the “Global Finance Minister of the Year” award from Euromoney in 1995. In 1996, Euromoney named him as Asian Finance Minister of the Year. In 1997, he was again recognized as Asian Finance Minister of the year, this time by Asiamoney. He is known nationally and internationally for public and international finance, having been Chairman of the APEC and ASEAN Finance Ministers (at the onset of the Asian Financial Crisis whose meetings he chaired that resulted in the landmark Manila Framework that prescribed the steps to exit the crisis) as well as member of the Boards of Governors of World Bank, IMF, and the ADB. He was Secretary of Finance (1994-1998) during the presidency of Fidel V. Ramos, and was widely recognized as the principal architect of the resurgence of the Philippine economy whose achievement was hailed by the international finance community. Prior to these posts, he also served as Chairman and CEO of the Development Bank of the Philippines and led its rehabilitation such that it was recognized by the prestigious international Banker Magazine during his tenure as one of the “world’s soundest banks.”

He is the past president of the Asian Institute of Management having retired from that position in May 2006 and until recently was a member of the AIM Board of Trustees. At present he is the Chairman of the Philippine Veterans Bank and also Chairman of the Board of Advisers of the RFO Center for Public Finance & Regional Economic Cooperation, which is an ADB Regional Knowledge Hub.

Dr. de Ocampo is a recipient of many international and national honors. In September 2001, he was named to the Ordre National de la Legion d’ Honneur by the Republic of France with the rank of Chevalier for his successful efforts and initiatives to promote closer Philippine-France relations. On the occasion of the Queen’s Diamond Jubilee, he was conferred by Her Majesty Queen Elizabeth II the Most Excellent Order of the British Empire (OBE) for his outstanding efforts in promoting Philippine-UK relations during his years in public service and more recently in his capacity as Chairman of the British Alumni Association. He has also been awarded the Philippine Legion of Honor, the highest honor conferred on Filipino civilians by the Republic of the Philippines in 1998 for his outstanding contributions to the country. He is one of the first ASEAN members of the Trilateral Commission, an international think-tank of distinguished global leaders and was also the first recipient of the Man of the Year Award from the Association of Development Finance Institutions of Asia Pacific (ADFIAP). He is a founding Partner of a Global Advisory Group (Centennial Group) based in Washington D.C. and is a Founding Director of a recently established Global Economic Forum: The Emerging Markets Forum. Dr. de Ocampo, who was the 1975 Ten Outstanding Young Men (TOYM) awardee in the field of National Economic Development for pioneering the Philippine rural electrification program, had been cited as one of the 500 Great Asians in 2001 and a recipient of several Baron’s Who’s Who awards. In 2004, he was elected to the Board of Advisors of the Conference Board, one of the world’s leading authorities in international business economics (based in New York). In 2006, Dr. de Ocampo was conferred with the Asian Human Resources Development Award by the Asia HRD Congress.

Dr. de Ocampo is a product of both De La Salle (grade school and high school) and Ateneo Universities. He received his MBA from the University of Michigan, a post-graduate diploma from the London School of Economics and has been conferred four Doctorates (Honoris Causa) by the De La Salle University in Business Administration, by the University of Angeles City in Public Administration, by the Philippine Women’s University in Laws, and by the San Beda College in Humane Letters.

Dr. de Ocampo had been and is Chairman and/or Board Member of several private companies both in the Philippines and abroad including, among others, the Centennial Group (Washington, D.C.), Centennial Asia Advisors Pte. Ltd. (Singapore), Investment & Capital Corporation of the Philippines (ICCP) Group of Companies, Alaska Milk Corporation, United Overseas Bank, ABS-CBN Broadcasting Corporation, Philippine Airlines, Meralco, Globe Telecom Inc., Philam Asset Management Inc., Metrobank, Seaboard Eastern Insurance Co., House of Investments, Rizal Commercial Banking Corporation, Robinson’s Land Corporation, EEI Corporation, AES Corporation (Philippines) and Phinma Corporation, etc. He is presently Co-Vice Chairman of the Makati Business Club, a Past President of the Management Association of the Philippines (MAP) and an Emeritus member of Financial Executives Institute of the Philippines (FINEX) who named its head office in his honor. He was recently elected as Board Director of the Global Reporting Initiative (GRI).

Dr Ngozi Okonjo-Iweala took office as WTO Director-General on 1 March 2021. She is a global finance expert, an economist and international development professional with over 40 years of experience working in Asia, Africa, Europe, Latin America and North America. Dr Okonjo-Iweala was formerly Chair of the Board of Gavi, the Vaccine Alliance. She was previously on the Boards of Standard Chartered PLC and Twitter Inc. She was appointed as African Union (AU) Special Envoy to mobilise international financial support for the fight against COVID-19 and WHO Special Envoy for Access to COVID-19 Tools Accelerator. She is a skilled negotiator and has brokered numerous agreements which have produced win-win outcomes in negotiations. She is regarded as an effective consensus builder and an honest broker enjoying the trust and confidence of governments and other stakeholders.

Previously, Dr Okonjo-Iweala twice served as Nigeria's Finance Minister (2003-2006 and 2011-2015) and briefly acted as Foreign Minister in 2006, the first woman to hold both positions. She distinguished herself by carrying out major reforms which improved the effectiveness of these two Ministries and the functioning of the government machinery. She had a 25-year career at the World Bank as a development economist, rising to the No. 2 position of Managing Director, Operations. As a development economist and Finance Minister, Dr Okonjo-Iweala steered her country through various reforms ranging from macroeconomic to trade, financial and real sector issues.

She is a firm believer in the power of trade to lift developing countries out of poverty and assist them to achieve robust economic growth and sustainable development. As Finance Minister, she was involved in trade negotiations with other West African countries and contributed to the overhaul of Nigeria's trade policy enabling it to enhance its competitiveness.

She is renowned as the first female and African candidate to contest for the presidency of the World Bank Group in 2012, backed by Africa and major developing countries in the first truly contestable race for the world's highest development finance post. As Managing Director of the World Bank, she had oversight responsibility for the World Bank's \$81 billion operational portfolio in Africa, South Asia, Europe and Central Asia. Dr Okonjo-Iweala spearheaded several World Bank initiatives to assist low-income countries during the 2008-2009 food crisis and later during the financial crisis. In 2010, she was Chair of the World Bank's successful drive to raise \$49.3 billion in grants and low interest credit for the poorest countries in the world.

As Minister of Finance in Nigeria, she spearheaded negotiations with the Paris Club of Creditors that led to the wiping out of \$30 billion of Nigeria's debt, including the outright cancellation of \$18 billion. In her second term as Finance Minister, Dr Okonjo-Iweala was responsible for leading reform that enhanced transparency of government accounts and strengthened institutions against corruption, including the implementation of the GIFMS (Government Integrated Financial Management System), the IPPMS (Integrated Personnel and Payroll Management System), and the TSA (Treasury Single Accounts).

Dr Okonjo-Iweala has been listed in the Top 100 Most Powerful Women in the World (Forbes, 2022, 2014, 2013, 2012 and 2011), as one of the Top 100 Most Influential People in the World (TIME, 2014 and 2021), one of the 25 most influential women (Financial Times, 2021), Minister of the Decade, People's Choice Award by Nigeria's This Day newspaper (2020), one of Transparency International's Eight Female Anti-Corruption Fighters Who Inspire (2019), one of the 50 Greatest World Leaders (Fortune, 2015), the Top 100 Global Thinkers (Foreign Policy, 2011 and 2012), the Top Three Most Powerful Women in Africa (Forbes, 2012), the Top 10 Most Influential Women in Africa (Forbes, 2011), the Top 100 Women in the World (The UK Guardian, 2011), the Top 150 Women in the World (Newsweek, 2011), and the Top 100 most inspiring people in the World Delivering for Girls and Women (Women Deliver, 2011). She has also been listed among 73 "brilliant" business influencers in the world by Condé Nast International.

Mr. Otorbaev has been graduated with honors from the Leningrad University (1978), received his Ph. D. from Lebedev Physical Institute (Moscow) (1981), and his Research Professorship in Moscow (1989). He worked in few research institutions, including visiting professor position at the Eindhoven University (The Netherlands) (1992-1996). From 1996 he is the CEO of Philips Electronics Representative office, the Vice-president of Philips Electronics in Central Asia. In 2001 he was appointed as a Special representative of the President of the Kyrgyz Republic on Foreign Investments, and at the same time he founded, and became the first Executive Director of the Public Association “Investment Round Table”, the NGO which is known for its contribution to the economic reform progress in the country. Between 2002 and 2005 he worked as a Deputy Prime Minister of the Kyrgyz Republic. After that he worked as a Senior Adviser in the European Bank for Reconstruction and Development (EBRD), based in London (2006-2011).

In addition to his involvement in government and business, Mr. Otorbaev is the founding member of the Board of Trustees of the American University in Central Asia, the only self-governing liberal arts university in the region since its inception in 1997. Mr. Otorbaev has been honorary member and invited speaker at numerous boards and forums on emerging markets development and investment.

He is the author of the recently published book “Central Asia’s Economic Rebirth in the Shadow of the New Great Game” (London and New York, Routledge, 2023).

Apart from this, he served as treasurer of the United Cities and Local Governments (UCLG) - an organization that represents and defends the interests of local governments at the global level.
